


## Nature is one of Lebanon County's major competitive advantages


### Demand for outdoor recreation may help attract future growth

### OUTDOOR RECREATION PROVIDES THOUSANDS OF JOBS IN LEBANON COUNTY EACH YEAR

The outdoor recreation industry is strong and growing, generating \$646 billion annually in the United States. However, the demand for outdoor recreation in Lebanon County is larger than the business capacity to meet it, and much of the retail business related to outdoor recreation leaks into surrounding areas. The trend for current residents is to spend more time outdoors, and this will continue with future growth. Outdoor recreation participants in Lebanon County save roughly \$67 million annually in avoided healthcare costs due to increased exercise.
